### **UK NON-DOMICILED OR NON-RESIDENT TAXPAYERS**

Non-Domiciled donors have elected to be taxed on the remittance basis for UK tax purposes and pay tax in the UK only on UK income and any remittances to the UK. Non-Resident donors are not UK residents and pay UK tax only on UK income. Both categories include donors who may also file a US tax return.
